There was a record turn-out of attendees and I have heard of no major incidents. So thank you for keeping us all safe. Tomorrow morning I will be attending a celebration hosted by Arlington Industries and the MEDC. They will be formally announcing that Arlington will be moving into our industrial park at 121 Peyerk Court. A big thank you to the Macomb Economic Development Corporation for all your efforts in securing this investment in Macomb County and more importantly close to home – here in Romeo.

Has everyone noticed how clean and spiffy the water tower looks? Thanks again to Tim Metz for getting the crew here to power wash it. It should also be inspected in the next few weeks to make sure everything a being maintained adequately. And lastly, don't forget to stop by our new Coffee House – MainsTreats and grab a latte then walk down to the mural, you can watch DIA artist Nicole MacDonald adding color to the outline. Be sure to join the DDA, Starkweather Arts Center and the DIA for the grand unveiling and dedication on Saturday October 12 during our harvest Day Celebration.

b. Clerk - Romeo Peach Festival was a great success for the Romeo Lions. I enjoyed being a judge for the Floral Parade. I would like to thank the Romeo Police

Department for keeping everyone safe during the festival weekend and to the DPW for cleaning up after everyone during festival weekend. Both of your departments contribute to the success of the Peach Festival.

Friday September 6 President Malzahn and spent some time with the seniors at the Community Center on Morton Street. Coffee was provided by Rule 62. We got a chance to meet a lot of seniors that utilize the programs there and enjoyed conversations about a variety of topics. Tuesday Sept 10 Macomb County Partners meeting that was held in Ray Township. Macomb County Economic and Development presented the meeting.

Thursday Sept 12, I attended the Michigan Association of Municipal Clerks Free Education Day in Mt. Pleasant. The morning had the Cybersecurity and Infrastructure Security Agency division of the Department of Homeland Security come speak about cyber security and computer networks. Most of the conversation revolved around cybersecurity for the upcoming 2020 elections. The next topic was the 2020 Census. The presentation was given by the Executive Director of the Census in Michigan. It was noted that in 2010 Michigan was the only state to LOSE population so this census count will be very important in this state. Next spring enumerators, people going to door to door, will be in the Village knocking on doors taking census count. Because it is in the US Constitution those employees are exempt from obtaining a Village of Romeo Solicitors Permit. So, watch out for them late spring of next year. Between January and April mailers from the Census will be coming to your mailbox. The Director also wanted us Clerks to pass along that the census is hiring! More information is at the Village office or online at 2020census.gov. The final topic was elections. Since proposal 3 passed last year many changes will be coming to elections in the year 2020. No-Reason Absentee will be big so that application will be worded different. The appearance of absentee envelopes and communications will be different, also. On October 12th, the Village of Romeo will be joining Bruce Township for an Electronic Recycle Day. It will take place at Bruce Township Hall, (The date was later corrected as October 19, 2019).
