ALL accessory buildings must comply to the **Village of Romeo Code of Ordinances**, specifically Article 9 of the R-1 Single Family Residential District Code. This includes, but is not limited to:

- All accessory buildings that are attached to a main building must still follow the regulations of said ordinance.
- Detached accessory buildings must be located only in a rear yard
- When on a corner lot, accessory buildings must observe the required front year setback from both streets
- No more than one (1) attached or detached accessory building shall be permitted for each lot, excluding garages
- Dwelling units with attached garages may be allowed not more than one (1) detached accessory building not to exceed two hundred fifty (250) square feet in total area. Dwelling units without an attached garage may be allowed not more than one (1) detached accessory building not to exceed seven hundred ninety (790) square feet in total area.
- No detached accessory building shall be located closer than ten *(10) feet to any main building, nor shall it be closer than five (5) feet to any side or rear lot line. In no instance shall an accessory building be located within a dedicated easement or right of way.
- Accessory buildings shall not exceed two (2) stores or twenty-five (25) feet in total height.
- A detached accessory building, when located on the same or adjoining lot, shall not involve any business, profession, trade, or occupation. No accessory building shall be used for residential purposes.

According to Section 9.03 of the **Village of Romeo Code of Ordinances**, AREA, HEIGHT, AND PLACEMENT requirements include:

- A minimum lot area of 7200 square feet
- A minimum lot width of 60 lineal feet
- A front yard setback of 25 lineal feet
- A minimum rear yard setback of 40 lineal feet
- A minimum side yard of 9-foot each
- A maximum height (stories/feet) of 2/25
- A maximum lot coverage of 35%
- A minimum floor area (square feet) of:

One story being 900 square feet, one and a half stories being 768 square feet first floor and 900 square feet total and two stories being 728 square feet first floor and 1456 square feet total
